

- Make check payable to: MARION COUNTY TREASURER(include Phone Number) Taxpayers can include multiple bills on one check. Cancelled check serves as receipt. Payments can be put in the Drop Box on the west side of the Court House. Please enclose a self-addressed stamped envelope if a receipt is desired. Taxes must be paid on or before the due dates. Do not mail cash payments.
- 2. Tax stubs MUST be presented at the time of payment. A \$1.00 Fee will be assessed for each duplicate bill.
- 3. Your payment is void if check fails to clear. There is an additional \$25.00 charge for all returned checks.
- 4. Payments may be made by MAIL or at the Treasurer's Office on the first floor of the Court House Room 105, or at most banks in Marion County. Office hours are 8:00AM 4:00PM Monday thru Friday.
- 5. Pay by Phone 1-844-934-2444 or by online Bill Pay services available through govpayments.com/il_marion, www.ilmarion.com, www.my.autoagent.com/login by using electronic checks with a \$1.50 fee for up to 20 parcels or 2.45% for debit or credit cards, and automatic bill pay.
- 6. Online Bill Pay through your bank: Create One Transaction for Each Property Index Number. Do Not combine more than one parcel for one transaction in Online Bill Pay. Include the Property Index Number and phone number on the memo portion of the transaction.
- 7. **Penalty Dates:** Interest is added at the rate of 1 ½% per month effective on the first day following EACH due date. Parts or fractions of a month shall be considered a month.
- 8. A \$10.00 fee will be added after delinquent notices are mailed.
- 9. After the tax sale (date will be indicated on delinquent notices) you must contact the County Clerk for a redemption amount.
- 10. **IF OWNERSHIP OF THIS PROPERTY CHANGED** <u>AFTER 2022</u> and other arrangements for payment of this tax bill has been made, it is your responsibility to forward this bill to the person or persons responsible for payment.
- 11. **IF YOUR MORTGAGE COMPANY IS TO PAY BILL**, it is your responsibility to forward this tax bill to them for immediate payment. Some Taxpayers still receive a tax bill even though bank escrow pays their taxes.
- 12. PAYMENT AFTER DELINQUENT NOTICES MUST BE IN THE FORM OF CASH, CASHIER'S CHECK OR MONEY ORDER. NO PERSONAL CHECKS.
